**A RESOLUTION RESPECTFULLY REQUESTING THE
DEPARTMENT OF BUDGET AND MANAGEMENT, TO
ALLOCATE FUNDS FOR THE SOME OF THE PRIORITY
PROJECTS OF THE MUNICIPAL GOVERNMENT OF TAYTAY,
PROVINCE RIZAL, AND FOR OTHER PURPOSES**

WHEREAS, pursuant to Office of the President's Executive Order No. 25, Series of 1936, as amended, the Department of Budget and Management ("DBM") is mandated to promote the sound, efficient and effective management and utilization of government resources as instrument in the achievement of national socioeconomic and political development goals;

WHEREAS, development at the local level will likewise benefit the national government in its overall goal of developing the whole country;

WHEREAS, there are several priority projects of the Municipal Government which are aligned with national programs, projects, and activities, that the Municipal Government will have difficulties funding for the year 2023;

WHEREAS, the Municipal Planning and Development Office determined the following projects as priority which the Municipal Government can request allocation from the DBM for the year 2023, to wit:

1. Construction of a Municipal Crematorium including Site Development – Proposed Budget of Twenty Million Pesos (Php20,000,000.00);
2. Construction of a Municipal Jail including Site Development – Proposed Budget of Thirty-Five Million Pesos (Php35,000,000.00);
3. Construction of a Municipal Animal Surgery Facility including Site Development – Proposed Budget of Thirty Million Pesos (Php30,000,000.00);
4. Construction of a Municipal Public Library including Site Development – Proposed Budget of Fifteen Million Pesos (Php15,000,000.00); and

5. Construction of the Taytay Municipal College Building including Site Development – Proposed Budget of One Hundred Million Pesos (Php100,000,000.00);

WHEREAS, in order to provide above and beyond *Serbisyong May Ngiti* to all Taytayeños, there is a need for the Municipal Government to request for assistance from the DBM to fund special projects of the Municipal Government;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, to hereby **RESPECTFULLY REQUEST FROM THE DEPARTMENT OF BUDGET AND MANAGEMENT, TO ALLOCATE FUNDS FOR THE SOME OF THE PRIORITY PROJECTS OF THE MUNICIPAL GOVERNMENT OF TAYTAY, PROVINCE RIZAL.**

RESOLVED FURTHER, that the following programs will be requested from the Department of Budget and Management, to wit:

1. Construction of a Municipal Crematorium including Site Development – Proposed Budget of Twenty Million Pesos (Php20,000,000.00);
2. Construction of a Municipal Jail including Site Development – Proposed Budget of Thirty-Five Million Pesos (Php35,000,000.00);
3. Construction of a Municipal Animal Surgery Facility including Site Development – Proposed Budget of Thirty Million Pesos (Php30,000,000.00);
4. Construction of a Municipal Public Library including Site Development – Proposed Budget of Fifteen Million Pesos (Php15,000,000.00); and
5. Construction of the Taytay Municipal College Building including Site Development – Proposed Budget of One Hundred Million Pesos (Php100,000,000.00).
