

**MEMORANDUM OF AGREEMENT**

**KNOWN ALL MEN BY THESE PRESENTS:**

This **MEMORANDUM OF AGREEMENT** made and entered in the Municipality of Taytay, Rizal, Philippines and this \_\_\_\_\_ day of \_\_\_\_\_, by and between:

**TAYTAY EMERGENCY HOSPITAL**, Province of Rizal, a Local Government Unit with seat of government at the Municipal Building, Taytay, Rizal, herein represented by the Municipal Health Officer, **ALDWIN B. AGUINALDO, M.D.**, hereinafter called **PARTY OF THE FIRST PART;**

- and -

**UNCIANO COLLEGES (ANTIPOLO), INC.**, an Institution created under the laws of the Philippines, with office address at **L. Sumulong Memorial Circle, Circumferential Road, Antipolo City**, a duly recognized Institution by the Commission on Higher Education, represented by the Vice President for Academic Affairs, **ERNESTO GENARO A. JOVEN, M.D., MAEd** referred to as the **PARTY OF THE SECOND PART.**

**WITNESSETH**

1. That the **PARTY OF THE FIRST PART** agrees and allows the affiliation and training of **RADIOLOGIC TECHNOLOGY STUDENT** of the **PARTY OF THE SECOND PART** subject to the policies, procedures and guidelines governing as an affiliation set forth: by the parties in accordance with the provisions of the **MUNICIPAL HEALTH OFFICE.**
2. That the **PARTY OF THE SECOND PART** shall be responsible for the following:

To provide didactic instructions to students as part of their related learning program and activities.

The unit assignment and rotation of students shall be based on the program design and schedule submitted to the **PARTY OF THE FIRST PART** specifying the inclusive dates, duration, time and location within the semester of affiliation.

That each student shall stay with the **PARTY OF THE FIRST PART** within the designated period assigned.

That all Radiologic Technology student shall stay with the **PARTY OF THE FIRST PART** shall comply with the rules and regulations by the Party of the First Part particularly the Municipal Health Office (MHO).

To pay the necessary fees imposed by the **PARTY OF THE FIRST PART** after being provided the statement account by the **PARTY OF THE FIRST PART.**

That in cases where damage to property / properties of the **PARTY OF THE FIRST PART** during and within the actual hours assigned, the **PARTY OF THE SECOND PART** shall pay or replace the damages, breakage of losses incurred.

That in the event of illness / injuries on the affiliating students of the **PARTY OF THE SECOND PART**

3. That the **PARTY OF THE FIRST PART** shall be responsible for the following:

To provide maximum opportunity and support to all affiliating students to gain experience and training utilizing all available resources, materials and equipment of **TAYTAY EMERGENCY HOSPITAL** without impairing its services to the clients.

That the **PARTY OF THE FIRST PART** shall provide facilities to include the following:

- a. Areas where practice of students are allowed
- b. Conference area
- c. Equipment and supplies

To recommend disciplinary measures or terminate the affiliation of any student who fails to comply with the regulations of the MHO and who commits acts detrimental to the health, safety, and welfare of the clients and personnel of the **PARTY OF THE FIRST PART**.

To provide the **PARTY OF THE SECOND PART** with a statement of account within the first day of training of affiliation to allow the **PARTY OF THE SECOND PART** to pay the required fees.

#### AFFILIATION FEE

4. That the **PARTY OF THE SECOND PART** agrees to pay an affiliation fee in connection with the training of its students to **THE PARTY OF THE FIRST PART** in the amount of Five Hundred Pesos (Php500.00) for the Hospital and Three Hundred Pesos (Php300.00) for the Radiologic Technologist Coordinator.

#### GENERAL POLICIES

5. At no time shall the interest and welfare of the client be subordinate to the conduct of the affiliation – training program.
6. All students shall be governed by the rules and regulations regarding conduct of training prescribed by the **PARTY OF THE FIRST PART** or his duly authorized representative during their term with the **PARTY OF THE FIRST PART**.

#### EFFECTIVITY AND DURATION OF AGREEMENT

7. This contract shall take effect upon signing hereof and within one (1) year there from as approved by the Municipal Health Officer of Taytay, Rizal.

Unless mutually revoked, this agreement shall be effective for one (1) year from execution hereof at may be renewed upon mutual terms of the Parties.
