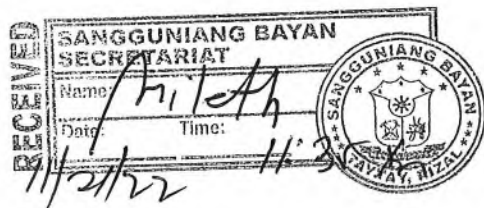


This is to follow-up our Letter dated July 1, 2022 manifesting an intent of the Department of Environment and Natural Resources (DENR) to enter into a Memorandum of Partnership Agreement (MOPA) with your Municipal Government, Taytay, Rizal to facilitate a process of updating/upgrading the land records of the Municipality.

Allow us to reiterate a phrase in our previous letter, "the DENR Administrative Order (DAO) No. 2011-06 was issued on May 23, 2011 entitled "*Prescribing Guidelines for the Implementation of Public Land Titling in Partnership with the Local Government Units*". The said policy seeks to provide sharing of resources, manpower, expertise, technical knowledge, funds and information to facilitate land titling, land transactions as well as land management with the respective Local Government Unit (LGU). Relative thereto, Memorandum Circular No. 2011-117 was issued by the Department of Interior and Local Government (DILG) enjoining local authorities to support the intention of DAO 2011-06 in integrating land titling programs in the Local Government Units (LGU)".

In this regard, we are reiterating our request for the formulation/execution of a MOPA to upgrading of land records within the Municipality for easy management and facilitation of land disposition.
