“A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO REPRESENT AND SIGN FOR THE MUNICIPAL GOVERNMENT OF TAYTAY, PROVINCE OF RIZAL, THE DEED OF DONATION WITH DEL ROSARIO FAMILY, REPRESENTED BY JULIANA DEL ROSARIO SANTOS, AND FOR OTHER PURPOSES”

WHEREAS, Section 5, Article II of the 1987 Constitution provides that, “[t]he maintenance of peace and order, the protection of life, liberty, and property, and the promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy”;

WHEREAS, Section 444(b)(1)(vi), Article I of Republic Act (“R.A.”) No. 7160, otherwise known as the Local Government Code provides that the Municipal Mayor, upon authorization by the Sangguniang Bayan, may represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, Section 444(2), Article I of R.A. No. 7160 provides that the Municipal Mayor shall enforce all laws and ordinances relative to the governance of the municipality and the exercise of its corporate powers, and implement all approved policies, programs, projects, services and activities of the municipality;

WHEREAS, Section 444(5), Article I of R.A. No. 7160 provides that the Municipal Mayor shall exercise such other powers and perform such other duties and functions as may be prescribed by law or ordinance;

WHEREAS, Section 33, Article III of R.A. No. 7160 provides that all Local Government Units are encouraged to enjoin and closely coordinate their efforts, services, and resources, and to cooperate with each other for the welfare of their inhabitants;

WHEREAS, the Del Rosario Family, hereby represented by Juliana Del Rosario Santos, intends to donate a portion of lot located at Callejon 2 Extension, Brgy. San Juan, Taytay, Rizal to the Municipal Government for the purpose of pavement enhancement;

WHEREAS, consistent with the goal of providing *Serbisyong May Ngiti* to all Taytayeños, the signing of said Deed of Donation will preserve the welfare of Taytayeño inhabitants within the jurisdiction of the donated portion of lot;

NOW, THEREFORE, on the Motion by Honorable _____, duly seconded and upon unanimous vote, be it:

RESOLVED, TO AUTHORIZE THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO REPRESENT AND SIGN FOR THE MUNICIPAL GOVERNMENT OF TAYTAY, PROVINCE OF RIZAL, THE DEED OF DONATION WITH DEL ROSARIO FAMILY, REPRESENTED BY JULIANA DEL ROSARIO SANTOS.
