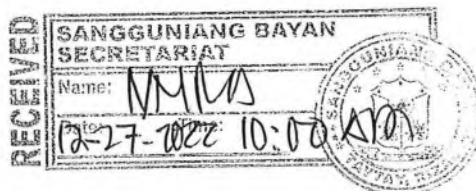

## DEED OF DONATION

### **MUNICIPAL GOVERNMENT OF TAYTAY AND PHILIPPINE NATIONAL POLICE**

This **DEED OF DONATION** is made and entered into by and between:

**MUNICIPAL GOVERNMENT OF TAYTAY, PROVINCE OF RIZAL** a government entity duly organized and existing under and by virtue of the laws of the Philippines, with principal address at Taytay Municipal Hall, Don Hilario Cruz Avenue, Club Manila East Compound, Barangay San Juan, Municipality of Taytay, Province of Rizal, represented herein by Allan Martine S. De Leon, MPA, **MUNICIPAL MAYOR** and hereinafter referred as the "**DONOR**".

**PHILIPPINE NATIONAL POLICE**, a government entity duly organized and existing under and by virtue of the laws of the Philippines, with principal address at Anti-Cybercrime Group Building Col. Lagman St. Bagong Lipunan Camp Crame, Quezon City, Metro Manila, Philippines 1100, represented herein by \_\_\_\_\_ and hereinafter referred to as the "**DONEE**".

#### **RECITALS:**

**WHEREAS**, there was an existing K9 Unit, a specialized group of law enforcement officers who use service dogs to perform the responsibilities of a general police officer;

**WHEREAS**, in lieu of the reorganization of the Municipal Government, the K9 Unit was deemed unnecessary and no longer needed by the Municipal Government in providing prompt and utmost public service for the general welfare of all its Taytayeño inhabitants;

**WHEREAS**, all the remaining service dogs in the K9 Unit are considered assets of the Municipal Government, but the same consistently requires food, nutrition, and shelter despite not being utilized by the Municipal Government;

**WHEREAS**, in consideration of the above-mentioned circumstances and for the welfare of the service dogs, it is hereby necessary to donate all the remaining service dogs of K9 Unit to the Philippine National Police, which has the resources and capability to care for the service dogs;

**WHEREAS**, the Philippine National Police is willing to receive the above-mentioned donation from the Municipal Government of Taytay;

**WHEREAS**, the DONOR warrants that it is duly authorized to provide donations to the DONEE pursuant to its internal rules and regulations, and that the same is being done solely out of the generosity of the DONOR;

**WHEREAS**, the DONEE is authorized by law and by its charter to accept the donation from the Municipal Government of Taytay;

**NOW, THEREFORE**, for and in consideration of the foregoing premises, the parties agree as follows;

1. For and in consideration of the generosity and liberality which the DONOR bears upon the DONEE, the DONOR absolutely and irrevocably donates in favor of the DONEE all the remaining service dogs which shall \_\_\_\_\_.
2. The DONEE acknowledges that the above-mentioned service dogs have been received in good health that it shall assume full responsibility of the service dogs' general well-being and shall be liable for claims against third persons for any fault or negligence on its part relative to providing utmost animal care.

Attached hereto as Annex "B" is the Acknowledgment Receipt as proof of actual receipt of the service dogs belonging to K9 Unit.

3. The DONOR affirms that this Donation is not made with intent to deceive its creditors and that it has reserved sufficient funds and property to sustain its operations. Likewise, the DONOR affirms that the Donation is being given out of the generosity of the DONOR.
4. The DONEE hereby accepts and receives this Donation and hereby manifests its gratefulness for the DONOR's generosity.
