“A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO REPRESENT AND SIGN FOR THE MUNICIPAL GOVERNMENT OF TAYTAY, PROVINCE OF RIZAL, THE DEED OF DONATION FOR THE REMAINING K-9 SERVICE DOGS WITH PHILIPPINE NATIONAL POLICE, AND FOR OTHER PURPOSES”

WHEREAS, Section 5, Article II of the 1987 Constitution provides that, “[t]he maintenance of peace and order, the protection of life, liberty, and property, and the promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy”;

WHEREAS, Section 444(b)(1)(vi), Article I of Republic Act (“R.A.”) No. 7160, otherwise known as the Local Government Code provides that the Municipal Mayor, upon authorization by the Sangguniang Bayan, may represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, Section 444(2), Article I of R.A. No. 7160 provides that the Municipal Mayor shall enforce all laws and ordinances relative to the governance of the municipality and the exercise of its corporate powers, and implement all approved policies, programs, projects, services and activities of the municipality;

WHEREAS, Section 444(5), Article I of R.A. No. 7160 provides that the Municipal Mayor shall exercise such other powers and perform such other duties and functions as may be prescribed by law or ordinance;

WHEREAS, there was an existing K9 Unit, a specialized group of law enforcement officers who use service dogs to perform the responsibilities of a general police officer;

WHEREAS, in lieu of the reorganization of the Municipal Government, the K9 Unit was deemed unnecessary and no longer needed by the Municipal Government in providing prompt and utmost public service for the general welfare of all its Taytayeño inhabitants;

WHEREAS, all the remaining service dogs in the K9 Unit are considered assets of the Municipal Government, but the same consistently requires food, nutrition, and shelter despite not being utilized by the Municipal Government;

WHEREAS, in consideration of the above-mentioned circumstances and for the welfare of the service dogs, it is hereby necessary to donate all the remaining service dogs of K9 Unit to the Philippine National Police, which has the resources and capability to care for the service dogs;

WHEREAS, consistent with the goal of providing *Serbisyong May Ngiti* to all Taytayeños, this Sangguniang Bayan Resolution is being issued;

NOW, THEREFORE, on the Motion by Honorable _____, duly seconded and upon unanimous vote, be it:

RESOLVED, TO AUTHORIZE THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO REPRESENT AND SIGN FOR THE MUNICIPAL GOVERNMENT OF TAYTAY, PROVINCE OF RIZAL, THE DEED OF DONATION FOR THE REMAINING K-9 SERVICE DOGS WITH PHILIPPINE NATIONAL POLICE.

RESOLVED FINALLY, that a copy of this Resolution shall be forwarded to the Office of the Municipal Mayor, and all concerned offices in the Municipal Government of Taytay.
