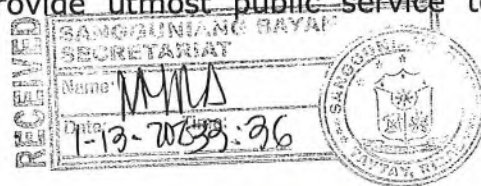

BAUTISTA, TO REPRESENT AND SIGN FOR THE MUNICIPAL GOVERNMENT OF TAYTAY, PROVINCE OF RIZAL, ALL INTERNET CONNECTION AND MOBILE POSTPAID PLANS WITH PLDT INC., AND SMART COMMUNICATIONS INC., AND FOR OTHER PURPOSES

WHEREAS, Section 4(a), Article II of Republic Act ("R.A.") No. 7925 otherwise known as the Public Telecommunications Policy Act of the Philippines provides that "*[t]elecommunications is essential to the economic development, integrity and security of the Philippines, and as such shall be developed and administered as to safeguard, enrich and strength the economic, cultural, social and political fabric of the Philippines. It is a fundamental objective of government to develop and maintain a viable, efficient, reliable and universal telecommunication infrastructure using the best available and affordable technologies, as a vital tool to nation building and development;*"

WHEREAS, Section 444(b)(1)(vi) of Republic Act ("R.A.") No. 7160, otherwise known as the Local Government Code provides that the Municipal Mayor, upon authorization by the Sangguniang Bayan, may represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, Section 444(2) of R.A. No. 7160 provides that the Municipal Mayor shall enforce all laws and ordinances relative to the governance of the municipality and the exercise of its corporate powers, and implement all approved policies, programs, projects, services and activities of the municipality;

WHEREAS, Section 444(5) of R.A. No. 7160 provides that the Municipal Mayor shall exercise such other powers and perform such other duties and functions as may be prescribed by law or ordinance;

WHEREAS, in accordance with the objectives of this Municipality towards continuous development and improvement of services provided to its constituents, the signing of said internet connection and mobile postpaid plans with PLDT Inc., and SMART Communications Inc., is hereby necessary;

WHEREAS, the Municipal Government of Taytay shall ensure that it will comply with all requirements under R.A. No. 9184 otherwise known as the Government Procurement Reform Act and all other applicable laws, rules, and regulations;

WHEREAS, to ensure the expeditious delivery of utmost *Serbisyong May Ngiti* to all Taytayeños, this Sangguniang Bayan Resolution is being issued;

NOW, THEREFORE, on the Motion by Honorable _____, duly seconded and upon unanimous vote, be it:
