Thank you, and may we all continue to provide utmost public service to all Taytayeños!

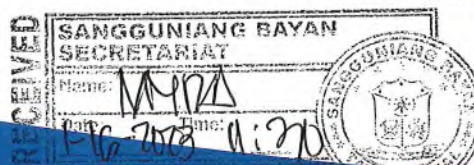

WHEREAS, Section 3(2), Article XV of the 1987 Constitution mandates the State to defend “[t]he right of children to assistance, including proper care and nutrition, and special protection from all forms of neglect, abuse, cruelty, exploitation, and other conditions prejudicial to their development”;

WHEREAS, Section 2(c) of Republic Act (“R.A.”) No. 9344 otherwise known as the Juvenile Justice and Welfare Act of 2006 “[t]he State recognizes the right of every child alleged as, accused of, adjudged, or recognized as having infringed the penal law to be treated in a manner consistent with the promotion of the child's sense of dignity and worth, taking into account the child's age and desirability of promoting his/her reintegration”;

WHEREAS, Section 444(b)(1)(vi) of Republic Act (“R.A.”) No. 7160, otherwise known as the Local Government Code provides that the Municipal Mayor, upon authorization by the Sangguniang Bayan, may represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, Section 444(2) of R.A. No. 7160 provides that the Municipal Mayor shall enforce all laws and ordinances relative to the governance of the municipality and the exercise of its corporate powers, and implement all approved policies, programs, projects, services and activities of the municipality;

WHEREAS, Section 444(5) of R.A. No. 7160 provides that the Municipal Mayor shall exercise such other powers and perform such other duties and functions as may be prescribed by law or ordinance;

WHEREAS, there is a newly established Children in Conflict with the Law ("CICL") Facility located at Velasquez, Sitio Bangiad Brgy. San Juan, Taytay, Rizal;

WHEREAS, conducive to the establishment of said Facility, New Electric Service Application in Meralco – Cainta Business Center is needed, and shall sign a Contract for Electric Service as part of the application process;

WHEREAS, in order to continuously provide utmost *Serbisyong May Ngiti* to all Taytayeños through the continuous development and improvement of facilities for the general welfare and security of CICL, the signing of said contract is hereby necessary;

NOW, THEREFORE, on the Motion by Honorable _____, duly seconded and upon unanimous vote, be it:
