WHEREAS, the Local Government of Taytay, Rizal acquired a property located at Binhing Pag asa St. Barangay Dolores Taytay Rizal and offer the same to use and be the site for the construction of Taytay Senior High School through their authorize representative, Assistant School Principal and Officer-in-Charge School Head Mr. Marco L. Lianza;

WHEREAS, the said property with a land area of 3,800 sq. m. covered by Tax Declaration No. 18-TY-002-14266, will be exclusively use for the construction of the TAYTAY SENIOR HIGH SCHOOL BUILDING and shall be built in accordance with the Municipal Site and Development Plan;
