A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. ALLAN MARTINE S. DE LEON, MAYOR, TAYTAY, RIZAL, TO NEGOTIATE AND ENTER INTO MEMORANDUM OF AGREEMENT FOR AND ON BEHALF OF THE MUNICIPALITY, WITH BIG HANDS AUSTRALIA LIMITED, REPRESENTED BY ITS DIRECTOR MR. J CARLOS BELLO, REGARDING THE COMMUNITY-BASED REHABILITATION PROGRAMS AND SERVICE PROJECTS FOR THE LOCAL HEALTH CARE SYSTEM, IN THIS MUNICIPALITY

WHEREAS, Republic Act 7160 otherwise known as The Local Government Code of 1991 provides in Section 16 thereof, to wit;

“Section 16. Every local government unit shall exercise the powers expressly granted, xxxxxxxxxx. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety.”

WHEREAS, record of the Department of Health revealed that stroke or brain attack is the third leading cause of death among Filipinos, with an estimated prevalence of 10.7% in 2018.

WHEREAS, stroke is a major health burden affecting the community and there is a need to mitigate the negative impact and burden of it to the individual, their family, and to the wider community;

WHEREAS, Big Hands Australia is a private international non-profit organization that upholds the vision of advancing rehabilitative healthcare and health literacy in poor communities in developing countries;

WHEREAS, the organization undertakes research, program evaluation and develops innovative sustainable methods of healthcare system interventions which would certainly enhance the capacity of our health workers including the Barangay Health Workers (BHWs);

NOW THEREFORE, BE IT RESOLVED, as it hereby resolved by the 12th Sangguniang Bayan of Taytay, Rizal, duly assembled in session, to hereby authorizes the Local Chief Executive, Hon. Allan Martine S. de Leon, Mayor, Taytay, Rizal, to negotiate and enter into a memorandum of agreement for and on behalf of the Municipality, with Big Hands Australia Limited, represented by its Founder and Executive Director Mr. J Carlos Bello, regarding the community-based rehabilitation programs and service projects for the local health care system, in this municipality.

RESOLVED FURTHER, that the Memorandum of Agreement on the subject shall be ratified by the Sangguniang Bayan before its full implementation.

RESOLVED FURTHERMORE, that the copies of this Resolution be furnished to all concerned for their information and appropriate action.
