**"A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR,
ALLAN MARTINE S. DE LEON, TO REPRESENT AND SIGN
FOR THE MUNICIPAL GOVERNMENT IN THE DEED OF
DONATION WITH PASCUAL LABORATORIES, INC., AND FOR
OTHER PURPOSES"**

WHEREAS, Section 444(b)(1)(vi) of Republic Act ("R.A.") No. 7160, otherwise known as the Local Government Code provides that the Municipal Mayor, upon authorization by the Sangguniang Bayan, may represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, Section 444(2) of R.A. No. 7160 provides that the Municipal Mayor shall enforce all laws and ordinances relative to the governance of the municipality and the exercise of its corporate powers, and implement all approved policies, programs, projects, services and activities of the municipality;

WHEREAS, Section 444(5) of R.A. No. 7160 provides that the Municipal Mayor shall exercise such other powers and perform such other duties and functions as may be prescribed by law or ordinance;

WHEREAS, Section 33 of R.A. No. 7160 provides that all Local Government Units are encouraged to enjoin and closely coordinate their efforts, services, and resources, and to cooperate with each other for the welfare of their inhabitants;

WHEREAS, the Pascual Laboratories, Inc. is willing to donate several vitamins and medicinal products to the Municipal Government to support its programs related to health and safety of Taytayeños;

WHEREAS, consistent with the goal of providing *Serbisyong may Ngiti* to all Taytayeños, the acceptance of the donation of Pascual Laboratories will benefit a lot of the Municipal Government's constituents;

NOW, THEREFORE, on the Motion by Honorable _____, duly seconded and upon unanimous vote, be it:

RESOLVED, TO AUTHORIZE THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, TO REPRESENT AND SIGN FOR THE MUNICIPAL GOVERNMENT IN THE DEED OF DONATION WITH PASCUAL LABORATORIES, INC.
