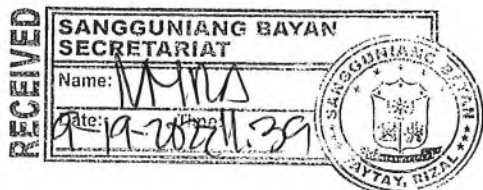

A RESOLUTION RECOMMENDING TO THE LOCAL CHIEF EXECUTIVE, MAYOR ALLAN MARTINE S. DE LEON, THE NOMINEES FOR THE POSITION OF THE HEAD OF THE OFFICE FOR SENIOR CITIZENS AFFAIRS TO THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL, AND FOR OTHER PURPOSES, AS ENDORSED BY THE OFFICERS AND MEMBERS OF THE FEDERATION OF SENIOR CITIZEN ACTIVE MEMBERS OF TAYTAY, INC. THROUGH THEIR LETTER DATED 7 SEPTEMBER 2022.

WHEREAS, Article II, Section 9 of the 1987 Constitution requires the State to *“promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living, and an improved quality of life for all”, including our most respected elderly;*

WHEREAS, Article III, Section 446 (a) (5) (xvii) of Republic Act (“R.A.”) No. 7160, otherwise known as the Local Government Code requires the Sangguniang Bayan, among others, to *“formulate policies and adopt measures mutually beneficial to the elderly and to the community; provide incentives for non-governmental agencies and entities and, subject to the availability of funds, appropriate funds to support programs and projects for the benefit of the elderly”;*

WHEREAS, Section 6 of R.A. No. 7432, as amended by R.A. Nos. 9257 and 9994 provides that the Office for Senior Citizens Affairs (“OSCA”) shall be headed by a *“senior citizen who shall be appointed by the mayor for a term of three (3) years without reappointment but without prejudice to an extension if exigency so requires”;*

WHEREAS, Section 6 of R.A. No. 7432, as amended by R.A. Nos. 9257 and 9994 likewise provides that *“head of the OSCA shall be appointed to serve the interest of senior citizens and shall not be removed or replaced except for reasons of death permanent disability or ineffective performance of his duties to the detriment of fellow senior citizens”;*

WHEREAS, Section 6 of R.A. No. 7432, as amended by R.A. Nos. 9257 and 9994 further provides that *“head of the OSCA shall be assisted by the City Social Welfare and Development officer or by the Municipal Social Welfare and Development Officer, in coordination with the Social Welfare and Development Office”;*

WHEREAS, Section 6 of R.A. 7432, as amended by R.A. Nos. 9257 and 9994 provided that *“shall be chosen from a list of three (3) nominees as recommended by a general assembly of senior citizens organizations in the city or municipality.”;*

WHEREAS, in order to ensure the continuity and sufficient provision of *Serbisyong May Ngiti* to the Senior Citizen Taytayeños, the Head of the OSCA must be appointed by the Municipal Mayor from proper nominees;



WHEREAS, meeting was held by the Federation of Senior Citizen Active Members of Taytay, Inc. ("FESCAMT") to determine the three nominees for the position of OSCA head stated as follows:

1. Alicia DL. Matienzo
2. Fernando Villamil
3. Lucas Ong

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the Sangguniang Bayan of the Municipality of Taytay, Province of Rizal duly assembled in session, to hereby **THE NOMINEES FOR THE POSITION OF THE HEAD OF THE OFFICE FOR SENIOR CITIZENS AFFAIRS TO THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL, AND FOR OTHER PURPOSES**, as endorsed by the officers and members of the **FEDERATION OF SENIOR CITIZEN ACTIVE MEMBERS OF TAYTAY, INC.** through their Letter dated 7 September 2022.

RESOLVED, FURTHER, that the Head of the Office for Senior Citizens Affairs shall be assisted by the Municipal Social Welfare and Development Officer, in coordination with the Municipal Social Welfare and Development Office.
