WHEREAS, Chapter II, Section 7 (f) of R.A. No. 7160, states that "[t]he National Government or the next higher level of local government unit may provide or augment the basic services and facilities assigned to a lower level of local government unit when such services or facilities are not made available or, if made available are inadequate to meet the requirements of its inhabitants";

WHEREAS, unpaved and damage roads result in traffic, road safety hazards and, flooding, which have an impact not only on our constituents but also to the local economy and businesses;

WHEREAS, various roads in Purok 1 Lupang Arenda, namely Block 3, 4, 6, 7, 8, 9, and 11, are requested to be concreted with drainage system improvement;

WHEREAS, various roads in Purok 4 Lupang Arenda, namely Block 19 (Mapagkumbaba St.), Block 20 (Maalalahanin St.), and Block 21 (Matiwasay St.), are requested by the Kaisahan ng Mamamayan sa Ilog Tapayan, Homeowners Association, Inc. (KAMIT HOMES Inc.) to be concreted with drainage system improvement;

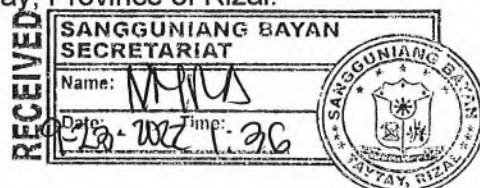
WHEREAS, the proposed project will considerably increase road safety, minimize accidents and flooding, and reduce delays for commercial and business movement in the Municipality;


