A RESOLUTION EARNESTLY REQUESTING THE MANILA ELECTRIC COMPANY (MERALCO) TO EXPEDITE THE INSPECTION, REPAIR AND MAINTENANCE OF STREETLIGHTS ALONG THE MUNICIPALITY'S MAJOR THOROUGHFARES AND FOR OTHER PURPOSES

WHEREAS, pursuant to Sec. 447 of R.A. 7160 also known as the Local Government Code of 1991, the Sangguniang Bayan shall enact ordinance, approve resolutions for the general welfare of the public;

WHEREAS, upon inspection to address the concern of the general public, we have identified that portions of our major thoroughfares namely Ortigas Avenue Extension (*from Cainta Boundary to Antipolo Boundary*), L. Wood St. (*now Benjamin Esguerra St*), Cabrera Road (*from Antipolo Boundary to Kaytikling Rotunda*) and Manila East Road (*from Kaytikling Rotunda to Angono Boundary in Muzon*), has defective and busted lamps on street light posts which cause risk at night;

WHEREAS, it is the responsibility of Manila Electric Company (MERALCO) to cause the replacement and maintenance of the Streetlights upon the report and recommendation of our Local Government from the Municipal Engineering Department;

WHEREAS, the Municipal Engineering Department already submitted reports and recommendations to Meralco Business center Cainta last August 2022;

WHEREAS, illumination of these major thoroughfares will help prevent accidents, lower crime opportunities and echo the attractiveness of our municipality;

WHEREAS, illumination and repair of these defective and busted lamps will likewise help our Municipality to identify other unlit areas that needs additional proposal and funding;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the Sangguniang Bayan of the Municipality of Taytay, Province of Rizal duly assembled in session, to hereby adopt **A RESOLUTION EARNESTLY REQUESTING THE MANILA ELECTRIC COMPANY (MERALCO) TO EXPEDITE THE INSPECTION, REPAIR AND MAINTENANCE OF STREETLIGHTS ALONG THE MUNICIPALITY'S MAJOR THOROUGHFARES AND FOR OTHER PURPOSES.**
