A RESOLUTION HUMBLY REQUESTING THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG) THROUGH SECRETARY BENJAMIN C. ABALOS JR. TO ALLOCATE FUNDS FOR THE PROPOSED REHABILITATION OF ADHIKA BRIDGE BARANGAY STA. ANA, TAYTAY, RIZAL

WHEREAS, Chapter II, Section 7 (f) of R.A. No. 7160, states that "[t]he National Government or the next higher level of local government unit may provide or augment the basic services and facilities assigned to a lower level of local government unit when such services or facilities are not made available or, if made available are inadequate to meet the requirements of its inhabitants";

WHEREAS, the Department of Interior and Local Government (DILG) through Secretary Benjamin C. Abalos Jr. have been helping Municipalities through the implementation of Local Government Support Fund-Assistance to Municipalities (LGSF-AM) Program with the support of ASEC Juabily P. Racho including the construction of Local bridges;

WHEREAS, during heavy rains and typhoons, our Municipality faces frequent flooding problems due to our low-elevation location and the overflowing of our major waterway which is Taytay River due to the blocking of lowly constructed and dilapidated Adhika Bridge and not making it passable to motorists and pedestrians;

WHEREAS, the reconstruction and rehabilitation of Adhika Bridge will ease the flow of flood water, smoothly traverse Taytay River and drain to Manggahan Floodway outfall;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the Sangguniang bayan of Taytay, Rizal, in a session duly assembled, to **HUMBLY REQUEST THE DEPARTMENT OF LABOR AND INTERIOR GOVERNMENT (DILG) THROUGH SECRETARY BENJAMIN C. ABALOS JR. TO ALLOCATE FUNDS FOR THE PROPOSED REHABILITATION OF ADHIKA BRIDGE BARANGAY STA. ANA, TAYTAY, RIZAL**
