### ORDINANCE NO. 13

AN ORDINANCE ESTABLISHING THE MUNICIPAL  
HEALTH OFFICE IN THE MUNICIPALITY OF  
TAYTAY AND CREATING THE POSITION OF  
MUNICIPAL HEALTH OFFICER.

By virtue of the powers vested upon the Sangguniang Bayan under Republic Act. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Bayan of Taytay duly assembled in session, do hereby ordained:

SECTION 1. The Municipal Health Office, pursuant to the provisions of the Local Government Code of 1991, is hereby established;

SECTION 2. Likewise, appurtenant to the last preceding paragraph, the position of Municipal Health Officer (department head) is hereby created.

SECTION 3. This Ordinance shall take effect upon approval.
