(SUPPLEMENTAL BUDGET NO. 2-FY 1997).**

WHEREAS, in Ordinance No. 3, series of 1997, (Supplemental budget No. 2 (GF)-FY 1997), rip-rapping of Coastal Road and gravel surfacing were given appropriations amounting to P150,000.00 and P250,000.00, respectively;

SECTION 1. That Statement of Expenditures for Supplemental Budget No. 2 (1997) is hereby amended as follows:





AMENDING CERTAIN PORTION OF LRF Form No. 152,
UNDER ORDINANCE No. 3 (ANNUAL BUDGET - 1997)

WHEREAS, there was a misdescription/misstatement in the
listing of appropriation and obligation by object under the
Non-CURER Expenditure (p. 43, LRF Form 152), which reads:

"Add to Municipal High School Fund - Account Code
No. 101-9999-2-11-001 - P150,000.00"

WHEREAS, instead of the term "add", it should have been
"amendment" of Municipal High School Fund.
