ORDINANCE NO. 26

**APPROVING SUPPLEMENTAL BUDGET
NO. 7 SERIES OF 1997**

WHEREAS, request for the approval of Supplemental Budget No. 7, FY 1997, has been presented to this August Body;

WHEREAS, the supplemental budget will come from the underestimated income on Internal Revenue Allotment (IRA) for the year 1997 in the amount of FOUR MILLION TWO HUNDRED EIGHTY THOUSAND NINE HUNDRED SEVENTY FOUR PESOS only (P4,280,974.00), as shown by the Certification duly issued by the Municipal Accountant copy of which is attached hereto and made an integral part hereof.

NOW, THEREFORE, BE IT RESOLVED, the Sangguniang Bayan, in a session duly assembled, hereby decrees:

SECTION 1. That Supplemental Budget No. 7, FY 1997 in the amount of P2,160,000.00 is hereby approved, summarized as follows:




SECTION 2. That release of said fund is subject to the usual accounting and auditing rules and regulations;

SECTION 3. That this Ordinance shall take effect upon approval.


