ORDINANCE NO. 12

AN ORDINANCE APPROPRIATING THE AMOUNT OF (P1,641,043.36), FROM PERSONAL SERVICES ON LUMP SUM APPROPRIATION AT THE OFFICE OF THE MAYOR TO THE PERSONAL SERVICES AT THE OFFICE ON HEALTH SERVICES, OFFICE ON SOCIAL WELFARE AND DEVELOPMENT AND URBAN POOR AFFAIRS OFFICE.

WHEREAS, there is a need to appropriate funds for the (2) Two Medical Officer III, (1) One Dentist II and (1) One Public Health Nurse II of the Office on Health Services;

WHEREAS, there is a need to appropriate funds for (1) one Social Welfare Officer IV; (1) one Social Welfare Officer I and (5) five Day Care Worker under the Office on Social Welfare and Development;

WHEREAS, there is a need to appropriate funds for (1) one Project Development Officer III (1) one Project Development Officer I and (1) one Clerk III under the Urban Poor Affairs Office;

WHEREAS, there is a need for the Re-alignment of funds from Personal Services on the Lump Sum appropriation at the Office of the Mayor to Personal Services at the Office on Health Services Offices on Social Welfare and Development and Urban Poor Affairs Office;

NOW THEREFORE, the Sangguniang Bayan of Taytay, Rizal in session duly assembled, hereby decrees;

SECTION I That the appropriation to wit:

Personal Services on Lump Sum Appropriation of the Office of the Mayor (P 618,506.32)

TO

Personal Services of the Office on Health Services (P618,506.32)

SECTION 2 That the appropriation to wit:

SECTION 3 That appropriation to wit:

Personal Services on Lump Sum appropriation of the Office of the Mayor (P330,999.80)

TO

Personal Services of the Urban Poor Affairs Office
(P330,949.80)


SECTION 4 That (P1,641,043.36) shall be the total amount of appropriation for Personal Services for the newly created positions under the aforesaid Offices;

SECTION 5 That the release of the said amount is subject to usual accounting and auditing rules and regulations.


SECTION 6 That this Ordinance shall take effect upon approval.


