ORDINANCE NO. 2

**AN ORDINANCE IMPOSING FEES ON 'TIANGGE' LOCATED
AROUND THE MUNICIPAL BUILDING DURING THE
CELEBRATION OF " ARAW NG PASASALAMAT " WHICH
SHALL COMMENCE TEN (10) DAYS PRIOR TO THE " ARAW NG
PASASALAMAT "**

WHEREAS, Ang Araw ng Pasasalamat in the Municipality of Taytay, Rizal is an Annual Tradition that is deeply rooted in the hearts and soul of every immemorial; and

WHEREAS, in observance of the tradition, "TIANGGE" is considered as one of the main attraction of the weeklong preparation in the

celebration of "ARAW NG PASASALAMAT" every 3rd Sunday of February such fees and charges to cover the cost of regulation, inspection and licensing and taxes on business in the operation of the same shall accrue exclusively to the Local Government Unit.

NOW THEREFORE, be it ordained, the Sanggunian Bayan of Taytay, Rizal in a regular session duly assembled, **DECREES THAT** :

Section 1. COVERED AREA - the "Tiangge" area shall cover the following streets:

- a.) Sumulong St. from Morga St. to Kadalagahan St;
- b.) Kadalagahan St. from Sumulong St. to Rizal Ave;
- c.) Rizal Ave. From Kadalagahan St. to Morga St.;
- d.) Morga St. from Rizal Ave. to Sumulong St.,

Section 2. STALL AREA - each stall area shall cover an area of one by two (1x2) meters (2 sq. m.)

Electrical Service Fee and Garbage Fee shall cover one (1) stall to be paid to the Municipal Treasurer excluding the Ten Pesos (P10.00) ticket as daily tax.

Section 3. APPLICANT - any person or group of person may be awarded with a stall giving priorities to the residents of the Municipality promoting local products. But in no case, shall an applicant is entitled to more than one stall.


Section 4. SPECIAL MAYOR'S PERMIT -upon payment of corresponding rental fees, the applicant shall apply for a Special Mayor's Permit amounting to Five Hundred pesos (P500.00).

- a.) Three Hundred Pesos (P300.00) - for every 2 square meter;
- b.) One Hundred Fifty Pesos (P150.00)- Electrical Service Fee;
- c.) Fifty Pesos (P50.00)- Garbage Fee;

Section 5. GRACE PERIOD - A period of two to three days after the "Araw ng Pasasalamat" shall be declared grace period, for the stall owners to clear the area.

Section 6. COLLECTING OFFICER - The Municipal Treasurer and his/her authorized representative shall issue the ticket and collect the daily tax.

Section 7. COMPROMISE SETTLEMENT - Except as otherwise provided, the Mayor is hereby authorized to enter into an "extra judicial" or



out -of- court settlement of an offense involving violations of any of the provisions of this Ordinance subject, however , to the following conditions;

1. That the offense does not involved fraud;
2. That the offender shall pay a **compromise settlement fee** of not less that Three Hundred Pesos (P300.00) but not more than Two Thousand Pesos (P2,000.00) as maybe agreed upon by both parties;
3. That the payment of the **compromise settlement fee** above mentioned shall not relieve the offender from the payment of the corresponding tax, fee or charge due for his as provided under this Ordinance, if he liable thereof.


Section 8. EXEMPTIONS - The following are possible for exemptions;

- a) Sponsors in the holding of Araw ng Pasasalamat.
- b) Charitable Institutions like Tahanan ng Walang Hagdanan, Associaiton of Blinds and Deaf, as well as Senior Citizens.


Section 9. EFFECTIVITY - This Ordinance shall take effect upon approval.
