**ORDINANCE NO. 10**

**AN ORDINANCE AMENDING RESOLUTION # 20 SERIES OF 1999 A RESOLUTION CREATING TEN (10) LEGISLATIVE STAFF EMPLOYEES AS CO-TERMINOUS OF THE SANGGUNIANG BAYAN MEMBER**

WHEREAS, the Sangguniang Bayan has approved Resolution # 20 series of 1999 " A RESOLUTION CREATING TEN (10) LEGISLATIVE STAFF EMPLOYEES AS CO- TERMINOUS OF THE SANGGUNIANG BAYAN MEMBER" dated February 4, 1999;

WHEREAS, certain portion of Resolution No. 20 Series of 1999 must be amended so as to comply with the LOCAL BUDGET CIRCULAR NO. 67 SERIES OF 1996 REVISED INDEX OF OCCUPATIONAL

**SERVICES, POSITION TITLE AND SALARY GRADES ( IOS) IN THE LOCAL GOVERNMENT;**

WHEREAS, the creation of position must be supported by an Ordinance;

NOW THEREFORE, the Sangguniang Bayan in session duly assembled, hereby decrees;

Section 1. That Resolution No. 20 Series of 1999 is hereby amended to read as follows;

**AN ORDINANCE CREATING TEN(10) LOCAL LEGISLATIVE STAFF EMPLOYEES II AS CO- TERMINOUS OF THE SANGGUNIAG BAYAN MEMBER**

WHEREAS, Sangguniang Bayan has Ten (10) members including the president of the Federations;

WHEREAS, Republic Act No. 7160, otherwise know as the Local Government Code of 1991 has allotted delicate and voluminous jobs of public interest into the member of the Sangguniang Bayan;

NOW THEREFORE BE IT ORDAINED AS IT HEREBY ORDAINED BY THE SANGGUNIANG BAYAN OF TAYTAY, in session duly assembled;

SECTION 1. Considering the fact that the population continue to rise unabated, compounded by the increase of duties and responsibilities it is proper to create Ten (10) Local Legislative Staff in order to meet the demands of the growing population;

SECTION 2. Ten ( 10 ) position for Local Legislative Staff Employee II with Salary Grade 4 be created to assist the Sangguniang Bayan Member;

SECTION 3. That this Ordinance shall take effect upon approval.


