**ORDINANCE NO. 11**

**AN ORDINANCE AMENDING RESOLUTION NO. 20 SERIES  
OF 2000 "A RESOLUTION CREATING ADDITIONAL  
PLANTILLA POSITION IN VARIOUS MUNICIPAL  
DEPARTMENT OFFICES.**

WHEREAS, the Sangguniang Bayan has approved Resolution No. 20 series of 2000 "A RESOLUTION CREATING ADDITIONAL PLANTILLA POSITION IN VARIOUS MUNICIPAL DEPARTMENT OFFICES.";

WHEREAS, certain portion of Resolution No. 20, Series of 2000 must be amended so as to comply with the LOCAL BUDGET CIRCULAR NO. 67 SERIES OF 1996, "REVISED INDEX OF OCCUPATIONAL SERVICES, POSITION TITLES AND SALARY GRADES (IOS) IN THE LOCAL GOVERNMENT.";

Section 1. Considering the fact that the population continues to rise unabated compounded by the increase of duties and responsibilities intended for various Municipal Department Offices and its constituents;


