WHEREAS, the re-alignment of funds needed to give better services to our constituents her at Taytay, Rizal;


NOW THEREFORE, the Sangguniang Bayan of Taytay, Rizal in session duly assembled, hereby decrees;



SECTION 2. That the release of said amount shall be subject to the usual accounting and auditing rules and regulations.


SECTION 3. That this Ordinance shall take effect upon its approval.


