TO GRANTS, AIDS AND SUBSIDIES IN THE SAME OFFICE**



WHEREAS, there is a need to re-align funds to the Office of the Vice Mayor.

P 20,000.00


TO

SECTION 2. That release of said amount shall subject to the usual Accounting and Auditing Rules and Regulations.


SECTION 3. That this Ordinance shall take effect upon its approval.

ENACTED, this 14th day of December, 2000 at the Session Hall Municipal Building, Taytay, Rizal.


