
WHEREAS, funding of said positions shall be subject to the provision of RA 7160 otherwise known as the Local Government Code of 1991 particularly Sec. 325;


RESOLVED FURTHER, that copies of this Ordinance be furnished all authorities concerned for their information and appropriate action.
