**ORDINANCE NO. 32**

**AN ORDINANCE AMENDING ORDINANCE NO.22  
SERIES OF 1997**

WHEREAS, the Sangguniang Bayan of Taytay has approved Ordinance No. 22 on October 23, 1997 mandating the holding of Fire Drills and Earthquake Drills in all Private and Public Schools at all levels in the Municipality of Taytay;

WHEREAS, there is a need to amend the title and other contents in order to sustain the implementation of the said ordinance;

NOW THEREFORE, the Sangguniang Bayan of Taytay, Rizal in session duly assembled, hereby decrees;

TITLE: Mandating the holding of Emergency Drills in all Private and Public Schools at all levels in the Municipality of Taytay.



ARTICLE 1. Fire Drills and Earthquake Drills be "EMERGENCY DRILLS".

ARTICLE 2. Fire Drills and Earthquake Drills be "EMERGENCY DRILLS".

ARTICLE 3. Emergency Drills must be conducted twice every year per school.

ARTICLE 4. Any School Principal that violates this Ordinance shall be held criminally liable for gross negligence, or as the court may see fit.

ARTICLE 5. This Ordinance shall take effect upon its approval.
