**ORDINANCE NO. 1**

**AN ORDINANCE REQUIRING ALL BUSINESS  
ESTABLISHMENT ENGAGED IN MOTORCYCLE  
DEALINGS, THIS MUNICIPALITY, TO INCLUDE  
HELMETS AS PART OF THEIR SALES PROMOTIONS.**

WHEREAS, the said promotion would shed light to the clients awareness on the importance of having helmet for safety measure purposes;

WHEREAS, the increasing rate of motorist accidents can be attributed to lack of information concerning the advantages of having such;

WHEREAS, more than eighty percent (80%) of the recorded accidents/incidents/ are motorist, as per Philippine National Police reports;

WHEREAS, public safety is of paramount concern by the Sangguniang Bayan as having been duly elected public officials;

THEREFORE BE IT ORDAINED, by the Sangguniang Bayan of Taytay, Rizal in session duly assembled that:

SECTION 1. Implementing Guidelines

- 1.1. The owner, manager, proprietors, President, undertakers, cooperators of any business entity, corporation, partnership, single proprietorship and joint ventures, are hereby required to submit a copy of the said promotion to the Office of Business Permit and License Section, this Municipality, for records and monitoring purposes.
- 1.2. This promotional advertisements shall be permanently and conspicuously within the establishment concerned that is visible to the public view;
- 1.3. The Local Chief Executive through Office of the Business Permit and License is hereby authorize to promulgate by Executive Memorandum Order the proper and necessary implementing Rules and Guidelines/Regulations;

SECTION 2. Penalty

Any Violation of the provisions of this Ordinance by any persons/entities enumerated under section 1 hereof shall be punished by a fine of not exceeding One Thousand Pesos (P1,000.00) or imprisonment of not more that six (6) months or both at the discretion of the court.




SECTION 3. Repealing Clause

SECTION 4. Effectivity


This ordinance shall take effect thirty days (30) after its publication so as to inform concerned authorities;


