ORDINANCE NO. 1

**REVISING THE GUIDELINES ON SCHOLARSHIP GRANTS
FOR DESERVING STUDENTS OF TAYTAY, RIZAL**

Be it Ordained by the Sangguniang Bayan that:

Section -1 Title:

This Ordinance shall be known as the “Revised Guidelines on
Scholarship Grants for Deserving Students of Taytay, Rizal.”

Section -2 Declaration of Policy.

The state shall give priority to education protect and promote the right of all citizens to quality education at all level, they shall be provided scholarship grants to deserving students:

Section -3 Requirements:

Students applicants must present the following to the Office of the Chairman Committee on Education for screening:

- a. General Average grade of 88% or its equivalent and must be 86% on all subject.
- b. Barangay Clearance for residency (Certification from the Commission on Election for residency or voter's I.D. xerox certified true copy)
- c. Certificate of Indigency from Municipal Social Welfare and Development (MSWD)
- d. Recommendation from District Supervisor on from school principal for academic and good moral character.
- e. Conduct interview after the submission of the requirements (NGO/Comm. On Education)
- f. Fill up the application form and submit 2x2 pictures
- g. Deadline of submission shall be on or before May 15 thereafter.

Section- 4 Nature and Extent of Scholarship Grants:

The scholarship grants are hereby extended to those who will qualify for the guidelines for the whole year applied for shall be:

P 5,000.00 – College Students
P 3,000.00 - High School Students
P 1,500.00 - Elementary School


Section- 5

To case several applicants were qualified and the scholar fund is not sufficient the following will be the basic of the grant:

- a. the earliest applicants to submit the complete requirement in Section 3 will be given priority.
- b. If the above is not applicants the available fund will be divided equally among qualified applicants (students from public school will be prioritized)

Section- 6

The Local Chief Executive can give special grant amounting to P 8,000.00 to a gifted and talented students who gained National or International Recognition.



The Sangguniang Bayan through a Resolution shall recommend to the Local Chief Executive an applicant who they evaluated as the most qualified.

Section 7- Penalty Clause

Any person found misrepresent or falsify the documents shall be penalized by a fine of Two Thousand Five Hundred Pesos (P 2,500.00) or imprisonment for a period not exceeding six (6) months or both such fine and imprisonment at the discretion of the court.

Section 8- Repealing Clause

All ordinances, executive orders, rules and regulations or parts thereof or conflict with or inconsistent with any provision of this Ordinance are hereby repealed amended or modified accordingly.

Section -9 Effectivity. This Ordinance shall take effect after the approval.

RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.

ADOPTED, this 27th day of March, 2008 at the Session Hall of the Municipal Building, Taytay, Rizal.


