ORDINANCE NO. 11

AMENDING ORDINANCE NO. 10, SERIES OF 2004

WHEREAS, the tremendous increase of petroleum products and economic crisis dictates the consideration of transportation fare increase, thus amendment for Ordinance 10, Series of 2004 is needed;

NOW, THEREFORE, BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF TAYTAY, RIZAL IN SESSION DULY ASSEMBLED HEREBY AMENDS ORDINANCE 41, SERIES OF 2004 that:

WHEREBY TRICYCLE FARES AND PASSENGERS Section 1. states that Tricycle Fares in Taytay , Rizal shall be Php 6.00 per person for the first kilometer and Php 1.00 for every succeeding kilometer. Students and senior citizens shall charge Php 1.00 less of basic fare.

HEREBY AMENDS TO

Section 1. Tricycle Fares increasing Tricycle Fares in Taytay, Rizal shall be Php 8.50 per person for the first kilometer and Php 1.00 for every succeeding kilometer. Students shall be charge less P1.00 and Senior Citizens shall charge Php 1.70 less of basic.fare.

Special Trip fares shall be Php 16.00 for the first kilometer and Php 1.00 for every succeeding kilometer. Students and senior citizens shall be charge Php 2.00 less of the special trip fare.

All TODA operating within the subdivision shall secure separate fare matrix from the TMTFRB after proper consultation from the homeowners concerned.

No other special trip fare is allowed unless authorized by the TMTFRB.
