ORDINANCE NO. 18

**APPROPRIATING THE AMOUNT OF THREE HUNDRED
SIXTY ONE MILLION SIX HUNDRED THIRTY SEVEN
THOUSAND TWENTY ONE PESOS ONLY (P361,637,021.00)
AS THE ANNUAL BUDGET OF THE MUNICIPALITY OF TAYTAY
PROVINCE OF RIZAL FOR THE FISCAL YEAR 2009**

By virtue of the power vested by the Republic Act 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Bayan of Taytay, Rizal assembled in session duly called for the public DO HEREBY ORDAINED, THAT;

SECTION 1. The estimated revenue and other sources of funds duly certified by the Municipal Finance Committee as to reasonableness of collection based on the present economic conditions and existing tax ordinances is hereby estimated at THREE HUNDRED SIXTY ONE MILLION SIX HUNDRED THIRTY SEVEN THOUSAND TWENTY

ONE PESOS ONLY (P361,637,021.00) as detailed in Annex A;

SECTION 2. The total estimated income of THREE HUNDRED SIXTY ONE MILLION SIX HUNDRED THIRTY SEVEN THOUSAND TWENTY ONE PESOS ONLY (P361,637,021.00) is hereby appropriated to various expenditures detailed in Annex B needed to carry out functions, projects and activities of the Municipality of Taytay for the Fiscal Year 2009;

SECTION 3.1 This Appropriation Ordinance shall contain the Local Expenditures Program presented per department/office in the following manner:

- Functional Statement, objectives and expected results
- Proposed New Appropriation Language
- Staffing and Compensation Profile
- Special Provisions

SECTION 4.1 The execution of this Budget shall comply with the budgeting guidelines and procedures prescribed in the Budget Operations Manual for Local Government Units;

4.2 The disbursement of authorized expenditures shall be based on the approved work and financial plan and the advice allotment issued by the Local Chief Executive;

4.3 The release of these funds are subject to the usual accounting and auditing rules and regulations;

SECTION 5. The Honorable Mayor is hereby authorized to enter into contracts relative to the implementation of this budget. He shall act in accordance with existing rules and regulations;


SECTION 6. The Sanggunian Bayan shall ratify all contracts entered into by Municipal Government of Taytay represented by the Municipal Mayor.

SECTION 7. The provisions of this ordinance shall take effect on January 1, 2009;

7.1. Any changes in this budget shall be made in accordance with the provisions of Section 321 and 336 of R.A. 7160;

SECTION 8. The Sanggunian Bayan shall ratify all program of works and appropriation and expenditures proposed by Special Bodies especially the School Board.


