ORDINANCE NO 6

**APPROVING SUPPLEMENTAL BUDGET NO. 3 "AN ORDINANCE
APPROPRIATING THE AMOUNT OF FORTY MILLION FOUR HUNDRED
THOUSAND PESOS (P 40,400,000.00) FROM PROCEED OF LOAN FROM
LANDBANK OF THE PHILIPPINES TO FUND THE CONSTRUCTION OF
SCHOOL BUILDINGS AND OTHER INFRASTRUCTURE PROJECTS IN
DIFFERENT LOCATIONS IN THE MUNICIPALITY**

WHEREAS, there is an immediate need for the construction of school buildings
and other infrastructure project in different locations in the municipality;

WHEREAS, the Municipality of Taytay through the Hon. Mayor George Ricardo
R. Gacula II has entered into a Omnibus Term Loan Agreement with Landbank of the
Philippines in the amount of ONE HUNDRED SEVENTY FIVE MILLION PESOS

(P175,000,000,00) wherein the construction of school buildings and other infrastructure projects are among the list of priority projects to be considered in the said agreement;

WHEREAS, the plans and specifications of the projects pertaining to this Ordinance shall be submitted to the Office of the Secretary to the Sangguniang to serve as record on file in aid of legislation;

WHEREAS, the Municipality of Taytay through the Hon. Mayor George Ricardo R. Gacula II has entered into a Sub-Loan Agreement in the amount of FORTY MILLION FOUR HUNDRED THOUSAND PESOS (P40,400,000.00) for the construction of school buildings and other infrastructure projects;

WHEREAS, there is a need to appropriate the said amount for the implementation of the given projects;

NOW THEREFORE, the Sangguniang Bayan of Taytay, Rizal in session duly assembled, hereby decrees;

SECTION 1. That the appropriation to wit:



ENACTED, this 12th day of March, 2010 at the Session Hall of the Municipal Building, Taytay, Rizal.


