ORDINANCE NO. 9

**APPROVING SUPPLEMENTAL BUDGET NO. 4. AN ORDINANCE
APPROPRIATING THE AMOUNT OF TWO MILLION EIGHTY NINE
THOUSAND SIX HUNDRED THIRTY EIGHT PESOS AND 68/100 (PHP
2,089,638.68) FROM THE OPERATION OF MARKET-UNAPPROPRIATED
RETAINED EARNINGS AS OF DECEMBER 31, 2009 TO FUND THE INITIAL
REHABILITATION OF THE NEW TAYTAY PUBLIC MARKET**

WHEREAS, there is a need for a supplemental budget to fund the initial rehabilitation of Market premises damaged by fire that occurred on May 27, 2010;

WHEREAS, Accounting Office has set PHP 2,089,638.68 as the surplus of operation for market for the year ending December 31, 2009 which is free and available for supplemental appropriation;

NOW THEREFORE, the Sangguniang Bayan of Taytay, Rizal in session duly assembled hereby decrees;

SECTION 1. That the Appropriation to wit:

TO

Rehabilitation of Market Premises

SECTION 2. That the release of the said amount shall be subject to the usual accounting and auditing rules and regulations.

SECTION 3. That the same rules and procedures with that of the FY2010 Annual Budget shall apply in the implementation of this appropriation ordinance.

SECTION 4. That this Ordinance shall take effect upon its approval .
