**ORDINANCE NO.2**

**APPROVING SUPPLEMENTAL BUDGET NO.3 AN ORDINANCE APPROPRIATING THE AMOUNT OF TWELVE MILLION NINE HUNDRED THOUSAND EIGHT HUNDRED SEVENTY THREE PESOS (PHP 12,900,873.00) FROM THE VARIOUS PROJECTS / PROGRAMS OF THE MUNICIPALITY OF TAYTAY AS WELL AS THE TOTAL AMOUNT OF ONE MILLION SIX HUNDRED THIRTY THREE THOUSAND FOUR HUNDRED SEVENTY NINE PESOS AND SIXTY NINE CENTAVOS (PHP 1,633,479.69) FROM THE UNIMPLEMENTED PROJECTS OF BARANGAY SAN JUAN, SAN ISIDRO AND MUZON TO VARIOUS PRIORITY PROGRAMS / PROJECTS OF THE MUNICIPALITY OF TAYTAY**

WHEREAS, MDC Resolution No. 13 – 002 was ratified by the Honorable August Body;

WHEREAS, there is a need for a supplemental budget to fund various priority projects / programs which are included in the MDC Resolution No. 13 – 002;




SECTION 4. That this ordinance shall be submitted to the Sangguniang Panlalawigan for review.


