ORDINANCE NO. 57 series of 2020

AN ORDINANCE RENUMBERING AND CLASSIFYING EXISTING ORDINANCES AND SUBSEQUENT ORDINANCES TO BE ENACTED BY THE SANGGUNIANG BAYAN OF TAYTAY AND FOR OTHER PURPOSES

WHEREAS, Section 48 of the Local Government Code, under Local Legislative Power, states that the Local legislative power shall be exercised by the Sangguniang Bayan for the Municipality;

WHEREAS, even before the inception of the Local Government Code, the Ordinances enacted by the Municipal Council of Taytay since 1945 were numbered ordinally and will reset to Ordinance No.1 every start of the calendar year and this practice was carried on by the 1st Sangguniang Bayan up to present;

WHEREAS, having identical Ordinance Numbers causes confusion in terms of identifying violations to be used for apprehensions, record keeping for concerned offices and departments, and archiving for the Sangguniang Bayan Secretariat;

WHEREAS, having a perpetual manner of recording enacted Ordinances will benefit not only the Local Government Unit of Taytay but the general public as well in terms of having easier references for the statutes and local laws being implemented in this Municipality;

NOW THEREFORE, be it resolved, as it is hereby resolved by the 11th Sangguniang Bayan of Taytay in a session duly assembled hereby ordains the following:

Section 1. Short Title - This Ordinance shall be referred to as “The Renumbering of Enacted Ordinances by the Sangguniang Bayan of Taytay”

Section 2. Scope - This Ordinance shall apply to all Ordinances Enacted by the 1st Sangguniang Bayan of Taytay from 1992 and shall cover all subsequent Ordinances to be enacted by the current and future Members of The Sangguniang Bayan of Taytay.

Section 3. Renumbering of Ordinances -The Sangguniang Bayan Secretariat shall renumber all enacted Ordinances starting with the first enacted ordinance by the 1st Sangguniang Bayan of Taytay in 1992. The renumbered existing Ordinances and future enacted Ordinances shall be recorded in the following format:

“Municipal Ordinance No. __, series of (year enacted) (Short Title if applicable)”
“Kautusan Pambayan Bilang __, serye ng (petsa ng pagkakapasa)”

No Municipal Ordinance enacted after the effectivity of the Local Government Code shall bear the same number regardless of the year of enactment.

Section 4. Classification of Ordinances - The Sangguniang Bayan Secretariat shall classify Ordinances according to its types, but not limited, to the following:

- General Regulation Ordinances
- Traffic Regulation Ordinances
- Zoning and Land Use Ordinances
- Budget and Finance Ordinances
- Environmental Protection Ordinances
- Health and Social Welfare Ordinances

Likewise, Ordinances shall also be sub-classified into Ordinances with Penalties and Ordinances Without Imposed Penalties for the enforcers of the implementing arms to have a narrowed selection of Ordinances to be used as reference in enforcing local laws.

Section 5. Archiving of Obsolete Ordinances - Upon the recommendation of the Sanggunian Secretariat and/or other Departments from the Municipal Government of Taytay, the Sangguniang Bayan, when necessary, shall adopt a Resolution formally Archiving outdated Ordinances.

All Archived Ordinances shall retain its Ordinance Number based on the provisions of this Ordinance.

Section 6. Ordinances with Amendments - All amended Ordinances shall be documented and filed by the Sanggunian Secretariat in a manner that the original part/s and amended part/s of the Ordinance shall appear on the final copy of the modified Ordinance.

The Original parts of the Ordinance shall be in plain text followed by the amended parts which shall be italicized and underlined for emphasis and distinction.

Section 7. Codification of Ordinances - The Sanggunian Secretariat and the Committee on Rules, Resolutions, Ordinances and Accreditation shall spearhead the Codification of all pertinent Ordinances that have the same tenor, subject matter and scope.

Section 8. Technical Working Group (TWG) – For purposes of this Ordinance, a Technical Working Group is hereby constituted which shall undertake the renumbering,

classifying and codifying all existing ordinances of this municipality. The TWG shall be headed by the SB Secretary and at least three (3) other members designated by its head from among the SB Secretariat.

Section 9. Soft Copy Documentation - The Sanggunian Secretariat shall make available a filed soft copy of the full text of all renumbered Ordinances from the 1st Sangguniang Bayan up to the present and future Ordinances that will be enacted by the Sanggunian.

All pages of the Ordinances shall bear a page number and the number of the Ordinance and its series as sampled below:

“Page 1 of 3, Ordinance No. 27, series of 2020”

Section 10. Information Dissemination - The Sanggunian Secretariat shall provide the concerned Departments or Offices of this Municipal Government the list of renumbered Ordinances necessary for the implementation and enforcement of specific Ordinances concerning their respective departments, offices or sections. All the Sangguniang Barangays shall also be furnished, at the least, a soft copy of all renumbered Ordinances for their information and possible adoption.


Section 11. Repealing Clause - All ordinances, resolutions, executive orders which are inconsistent with or contrary to any of the provisions of this Ordinance are hereby repealed or modified accordingly.

Section 12. Separability Clause - If for any reason/s, any part/s, section/s or provision/s of this Ordinance shall be held or declared unconstitutional or invalid, the remaining part/s thereof which are not affected thereby, shall continue to be effective and in full force.

Section 13. Effectivity Clause - This Ordinance shall take effect fifteen (15) days upon approval and posting in all conspicuous places.
