ORDINANCE NO. 682 series of 2020

AN ORDINANCE AMENDING SECTION 8 SUBSECTION A, B & C, AND SECTION 13 OF ORDINANCE NO. 675 SERIES OF 2020

WHEREAS, President Rodrigo Roa Duterte announced on November 30, 2020 that the Province of Rizal remains under Modified General Community Quarantine (MGCQ) from December 1 to 31, 2020;

WHEREAS, to ensure continuity of the national agencies effort and measures to cascade down to the local community for implementation in battling the effect of COVID-19 Pandemic, an updated local legislation of guidelines for this purpose is needed;

WHEREAS, the 11th Sangguniang Bayan passed Ordinance No. 675 series of 2020: An Ordinance Prescribing the Updated Guidelines and Regulation of Mobility in the Municipality of

Taytay, Province of Rizal declared as one of the areas under Modified General Community Quarantine, last October 20, 2020;

WHEREAS, to further open up the economy and help the business sector in the municipality, the increase of business operations is needed;

WHEREAS, the 11th Sangguniang Bayan finds the need to amend Section 8 subsection A, B & C and Section 13 of Ordinance No. 675 series of 2020 to best serve the purpose;

NOW THEREFORE, be it ordained by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, that:

Section 1. Operation hours of some establishment shall be extended with conditions. Thus, Section 8 A, B and C of Ordinance No. 675 series of 2020 is hereby amended and shall be read as follows:

Section 8. Allowable Hours of Operation for Specified Establishments – The following establishments shall be allowed to operate on specified hours indicated below:

A. Food Establishments – shall be allowed to operate from 5:00 AM to 9:00 PM. Food handlers shall be required to wear protective/transport masks, gloves and hairnet at all times. All customers are highly encouraged to bring their own containers and bags for the said purpose. All establishments shall provide queues/lines that practice strict social distancing from the entrance up to the payment area. No Facemask and Face shields / safety eye shields / safety protective goggles, No Entry.

A.1 Food Deliveries shall be allowed for up to 24 hours service provided that delivery personnel have proper company ID and license. The 24 hours service is NOT applicable for Dine In and Take Out.

B. Supermarkets/Groceries/Convenience Stores/Sari-Sari Store - shall be allowed to operate for fourteen (14) hours but not exceeding curfew hours, the sari-sari store shall be allowed to operate only for essential products from 7:00 AM to 9:00 PM, provided that Social Distancing is observed at all times especially when queuing for payment. Priority lanes for Senior Citizens or PWD's shall be provided or designated in all stores following the provisions of existing laws. All establishments shall provide queues/lines that practice strict social distancing from the entrance up to the payment area. No Facemask and Face shields / safety eye shields / safety protective goggles, No Entry.

B.1 Convenience Stores shall be allowed to operate on a 24 hours basis provided that the liquor ban is strictly observed based on Section 13 of this Ordinance.

C. Drug Store/Pharmacy - shall be allowed to operate for *twenty-four (24) hours*, provided that Social Distancing is observed at all times especially when queuing for payment. Priority lanes for Senior Citizens or PWD's shall be provided or designated in all stores following the provisions of existing laws. All establishments shall provide queues/lines that strictly practice social distancing from the entrance up to the payment area. No Facemask and Face shields / safety eye shields / safety protective goggles, No Entry.

Section 2. Additional prohibition on Liquor Ban shall be added. Thus, Section 13. of Ordinance No. 675 series of 2020 is hereby amended and will be read as follows:


Section 13. *Regulation on Sale of Liquor – The sale of all types of alcoholic drinks shall be prohibited from 10:00 PM up to 5:00 AM the next day.* Consuming of any alcoholic drinks in public places shall be strictly prohibited at all times.

Section 3. Separability Clause - If any provision of this ordinance is held invalid or unconstitutional, the same shall not affect the validity and effectivity of the other provisions hereof.

Section 4. Effectivity Clause - This ordinance shall take effect immediately and upon approval. This ordinance shall likewise be in effect every time that the municipality is placed under Modified General Community Quarantine (MGCQ) by the National Government.


