ORDINANCE NO. 702 series of 2021

AN ORDINANCE PRESCRIBING THE USE AND ISSUANCE OF AN ORDINANCE VIOLATION TICKET BY THE IMPLEMENTING ARM OF THE BARANGAY WHEN A VIOLATION OF ANY EXISTING TAYTAY MUNICIPAL ORDINANCE THAT THE BARANGAY IS INCLUDED AS IMPLEMENTOR IS COMMITTED AND FOR OTHER PURPOSES

WHEREAS, Section 16, General Welfare clause of the Local Government Code states that: "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 384 of the Local Government Code states that: "the Barangay serves as the primary planning and implementing unit of government policies and Section 388 further declares the Punong Barangays, Sangguniang Barangay Members as persons of authority and other





Barangay officials may be designated by law or ordinance and charged with the maintenance of public order, protection and security of life and property;

WHEREAS, to streamline the process of enforcing the penalty clauses of existing Municipal Ordinances, recording and penalizing apprehended violators by the Barangay Local Government Units, it is but fitting for each Barangays to have their corresponding Ordinance Violation Tickets (OVT) on hand;

ST.

NOW, THEREFORE, be it ordained by the 11th Sangguniang Bayan of Taytay, Rizal in a session duly assembled that:

Section 1. SHORT TITLE – This Ordinance shall be known as the MUNICIPAL ORDINANCE VIOLATION TICKETS (MVOT) FOR BARANGAY ORDINANCE.

Section 2. SCOPE – All Barangay Local Government Units in Taytay shall produce their respective MUNICIPAL ORDINANCE VIOLATION TICKETS to be issued by the Barangay personnel to apprehended violator/s of any existing enacted Municipal Ordinances in Taytay, Rizal with corresponding fines and penalties.

Section 3. CONTENT OF ORDINANCE VIOLATION TICKET – All MUNICIPAL ORDINANCE VIOLATION TICKETS to be produced by the respective Barangays shall be in consonance with the details on the OVT of the Municipal Local Government Unit of Taytay as stated in Section 2 of Taytay Ordinance No. 665 series of 2020 which include the following details:

- Municipal Ordinance Violated
- Penalty Fee to be paid
- The number of offence (to be filled-up by the data bank of Barangay records)
- Signature and Printed Name and Office or Department of the Deputized Apprehending Officer
- Footnote: That this Ordinance Violation Ticket applies only to violations of Ordinances in the Municipality of Taytay, Rizal
- Remarks (refused to sign, refused to pay, refused to accept, etc.)

Section 4. PAYMENT – All payments for the penalty fees for MOVTs issued by the Barangay shall only be paid to the Treasury Department of the Barangay with an official receipt to be given to the violator who have paid his/her penalty fee.

Section 5. PROCEEDS – All proceeds that will come from the collected payments for Municipal Ordinance violations using the MOVT issued by the Barangay shall be accorded in full to the issuing Barangay.

The Sangguniang Barangay may enact an incentive scheme for their duly deputized enforcers and implementors of existing Municipal Ordinances following pertinent laws and accounting procedures.

Section 6. DATA BANK – The Barangay Secretary shall keep a data bank and record the details, not limited to, of the name, address and contact number of violators for purposes of determining the number of offences that have been committed in reference for the amount to be paid as penalty fee and possible intervention for habitual violators.

The Barangay Secretary is hereby tasked to coordinate regularly with the Sangguniang Bayan Secretariat for the updated list of statutes that shall be included in the scope of this Ordinance.

Section 7. INTERPRETATION CLAUSE — In the event that there is a conflict of interpretation regarding the existing Taytay Municipal Ordinances that the barangay is included as implementor, the interpretation of the Sangguniang Bayan shall prevail.

Ordinance No. 702 Series of 2021 Page 2 of 3 pages **Section 8. REPEALING CLAUSE** - All ordinances, resolutions, local executive orders or any administrative issuances found to be inconsistent with any provision of this ordinance are hereby repealed or modified accordingly.

Section 9. SEPARABILITY CLAUSE - In case that any provision of this Ordinance is declared as unconstitutional or invalid by a competent court, the remaining provisions not affected thereby shall continue to be in effect.

Section 10. EFFECTIVITY CLAUSE - This ordinance shall take effect fifteen (15) days after posting in conspicuous places in the Municipality and Barangay Halls.
