## ORDINANCE NO. 712 series of 2021

### AN ORDINANCE CREATING THE TAYTAY GARMENTS COUNCIL DEFINING ITS FUNCTION AND COMPOSITION AND FOR OTHER **PURPOSES**

WHEREAS, Taytay, Rizal is now known nationwide as the Garments Capital of the Philippines;

WHEREAS, the local garments industry had given opportunities to thousands of small and medium entrepreneurs;

WHEREAS, the local garments industry also attracted a lot of garments materials and accessories suppliers to invest in our locality;

WHEREAS, a local council will establish a harmonious business relationship among all stakeholders;

DUE TO THE FOREGOING, IT IS HEREBY ENACTED, by the Sangguniang Bayan of Taytay, Rizal, that:

Section 1. Title - This ordinance shall be known as the "TAYTAY GARMENTS COUNCIL ORDINANCE".

**Section 2. Composition** - The Taytay Garments Council shall be composed of the following members or their official representatives:

- A. Chairman Municipal Mayor
- B. Members:
  - 1. (2) Sangguniang Bayan Member Chairperson of the Committee on Labor & Employment, Human Resources, Trade, Commerce and Industry and Committee on Privatization, Economic Enterprises, Market and Slaughterhouse
  - 2. (1) Representative of the Business Permit & Licensing Office
  - 3. (1) Head of the Tourism Office
  - 4. (1) Head of the MPDO
  - 5. (1) Legal Officer
  - 6. (1) Representative from Taytay-PNP
  - 7. (3) Representative from duly organized and BPLO registered garment vendors (magti-tiangge), duly selected among themselves
  - 8. (3) Representative from the duly recognized garment vendors (tiangge) organizers, duly selected among themselves
  - 9. (1) Representative of Philippine Chambers of Commerce and Industry (PCCI) Taytay Chapter

Section 3. Functions - The Taytay Garments Council shall have the following functions.

- A. The council shall formulate policies that will stimulate, support, secure, stabilize and sustain the local garments industry.
- B. The council shall formulate policies that will establish a harmonious relationship among all stakeholders.
- C. The council shall recommend to the Sangguniang Bayan any legislative measures that are necessary for the growth of the garments industry.
- D. The council shall coordinate with Dept. of Trade Industry (DTI), Dept. Of Tourism (DOT) and other concerned local and national gov't agencies.
- E. The council shall recommend to the LGU sanctions to any garment's vendors and textile vendors or suppliers who were found to be practicing deceptive, fraudulent or unfair market competition, to wit:
  - 1. Trademark infringement
  - 2. Product disparagement (making false claims about a competitor's product)
  - 3. Breach of a restrictive covenant
  - 4. Breach of Business Permits

**Section 4. Meetings** - The Taytay Garments Council shall meet every first Friday of the month or as the need arises. The meetings of the council shall be open to all concerned persons relative to the garments industry. But the council had the discretion to declare a closed-door meeting if needed.

**Section 5. Repealing Clause** - All ordinances, resolution, orders and decrees or parts thereof which are inconsistent with any provision of this ordinance are hereby repealed or modified.



**Section 6. Separability Clause -** If, for any reason/s any part or provision of this ordinance is held to be unconstitutional or invalid, other parts or provisions hereof that are not affected shall continue to be in full force and effective.

**Section 7. Effectivity -** This ordinance shall take effect ten (10) days after its posting in the bulletin boards of the Sangguniang Bayan of Taytay, Rizal and at the entrance of Municipal Building and at least one other conspicuous place in the municipality.
