ORDINANCE NO. 724 series of 2021

AN ORDINANCE ABOLISHING THE THREE (3) PLANTILLA POSITIONS OF AGRICULTURAL TECHNOLOGIST (SG-10) UNDER THE OFFICE OF AGRICULTURAL SERVICES OF THE MUNICIPAL GOVERNMENT OF TAYTAY, RIZAL, CREATING THE THREE (3) PLANTILLA POSITIONS FOR ANIMAL KEEPER 1 (SG-4) AND ONE (1) PLANTILLA POSITION FOR ANIMAL KEEPER 2 (SG-6) THEREIN, AND FOR OTHER RELATED PURPOSES

WHEREAS, the three (3) plantilla positions of Agricultural Technologist (SG-10) existing under the Office of Agricultural Services has long been vacant to this date, remain unfilled as no applicant was qualified thereto;

WHEREAS, Section 76 of R.A. 7160 explicitly empowered every Local Government Unit to design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability;

WHEREAS, the enforcement not only of the existing laws and ordinances but also future policies and regulations about the proper care and keeping of pets and animals has been the growing concerns which makes the Office of Agricultural Services becoming more relevant in discharging its mandates on this regard;

WHEREAS, the abolition of the three (3) existing plantilla positions of Agricultural Technologist that remain non-functional and unutilized is thus necessary, to better maximize existing appropriation made therefor, by creating other relevant plantilla positions pressingy needed therein, such as three (3) Animal Keeper 1 (SG-4) and one (1) Animal Keeper 2 (SG-6);

NOW THEREFORE, BE IT ENACTED, as it is hereby enacted, by the 11th Sangguniang Bayan of Taytay, in session duly assembled, that:

SECTION 1. Abolition - The three (3) plantilla positions of Agricultural Technologist (SG-10) under the Office of Agricultural Services are hereby abolished, and all funding and appropriation for the said positions shall be reverted to the General Fund.

SECTION 2. Reserved Lumpsum Appropriation - The appropriation allotted for the said positions in the Annual Budget as reverted herein, shall be reserved as a lumpsum appropriation under the Office of Agricultural Services in the Annual Budget FY 2022 for the needed plantilla positions which shall be created under the succeeding section.

SECTION 3. Creation – The three (3) plantilla positions for Animal Keeper 1, with corresponding Salary Grade of 4 (SG-4) and one (1) plantilla position for Animal Keeper 2, with a Salary Grade of 6 (SG-6), are hereby created under the Office of Agricultural Services of the Municipal Government of Taytay, Rizal.

SECTION 4. Miscellaneous Provision - The New Organizational Chart of the Office of Agricultural Services of the Municipal Government of Taytay, Rizal, reflecting the plantilla positions herein created, as well as the level of competency or qualification standards prescribed therefor, including the respective duties and responsibilities to be performed thereunder, shall be appended to, and made as an integral part of this ordinance.


SECTION 5. Separability Clause - In case any part or provision of this Ordinance is declared invalid, the other parts or provisions not affected by the declaration of invalidity shall remain in force.

SECTION 6. Repealing Clause – Any ordinance or parts thereof, in conflict with the provisions of this Ordinance is hereby repealed or modified accordingly.

SECTION 7. Effectivity - This Ordinance shall take effect upon its approval.
