RESOLUTION NO. 4

APPROVING A "JOINT PROJECT" BETWEEN THE MUNICIPAL GOVERNMENT OF TAYTAY AND THE VETERANS FEDERATION OF THE PHILIPPINES, TAYTAY POST, OF THE PROJECT "VETERANS MONUMENT AND MUNICIPAL PARK", TO BE CONSTRUCTED AT THE MIDDLE OF THE ISLAND OF THE MANILA EAST ROAD AND RIZAL AVENUE, BRGY. SAN JUAN, TAYTAY, RIZAL.

WHEREAS, the Sangguniang Bayan in its session dated January 5, 1995, presented for deliberation a letter from the Veterans Federation of the Philippines, Taytay Post, requesting financial support for the fulfillment of their project cited above;

WHEREAS, after a thorough deliberation between the SB Members and the representative of the Federation of the Veterans of the Philippines, Taytay Post, it has been agreed upon to approve a "Joint Project" of which the submitted bill of materials and cost estimate amounting to P133,525.00 to be supplied by the Municipal Government of Taytay and the cost of labor in the amount of P45,000.00 will be shouldered by the said VFP-Taytay Post;

WHEREAS, considering that this monument is an earmark and symbol of the Veterans who sacrificed and bestowed their lives during World War II, it is just fair and proper that said request be granted;

After due deliberation and exchange of ideas, on motion of Coun. Dennis J. Eguerra seconded by Coun. Carlos V. Borja, it was,


RESOLVED, as it is hereby being resolved, to approve as it is hereby approved a "Joint Project" between the Municipal Government of Taytay and the Veterans Federation of the Philippines, Taytay Post of the project "Veterans Monument and Municipal Park" to be constructed at the middle of the island of the Manila East Road and Rizal Avenue, Brgy. San Juan, Taytay, Rizal;

RESOLVED FURTHER, that the expenses for the materials of said project amounting to P133,525.00 will be supplied by the Municipal Government of Taytay and the expenses for labor amounting to P45,000.00 will be shouldered by the Veterans Federation, of the Philippines Taytay Post;

RESOLVED FURTHERMORE, to send copies of this Resolution to the authorities concerned for their information and appropriate action.


