WHEREAS, the said Children Recreational Parks and Playground shall be known as "PARAISO NG KABATAAN NG TAYTAY";

UNANIMOUSLY RESOLVED, as it is hereby unanimously resolved, by the Sangguniang Bayan of Taytay, petition, as it hereby petition, the Local Chief Executive to set aside the property known as the Old Taytay Public Market Compound as a children Recreational Parks and Playground" to be known as "PARAISO NG KABATAAN NG TAYTAY", and to cause its development for such purpose.
