**RESOLUTION NO. 57**

A RESOLUTION REQUESTING THE OFFICE OF  
THE PRESIDENT THROUGH THE DEPARTMENT  
OF HEALTH (DOH) FOR THE RELEASE OF  
FINANCIAL ASSISTANCE NECESSARY FOR THE  
IMPLEMENTATION OF REPUBLIC ACT NO. 7305,  
OTHERWISE KNOWN AS THE MAGNA CARTA OF  
PUBLIC HEALTH WORKERS.

WHEREAS, pursuant to Sec. 19 of R.A. No. 7305, the Magna Carta of Public Health Workers, stipulates that the salary scales of Public Health Workers whose salaries are appropriate by Local Government Unit shall not be less than those provided for Public Workers of the National Government;

WHEREAS, as per deliberation and exchanging of explanations between our local health officers, the Municipal Treasurer, Budget Officer and Accountant together with the Chairman of the Committee on Health and Sanitation and Finance and Budget, Appropriations agreed that upon study of

the computation of the difference or whatever benefit these Health Workers will receive will be submitted by the Budget Officer to the higher ups for proper action. So therefore be it.

RESOLVED, as it is hereby resolved, the Sanggunian Bayan of Taytay, hereby request the Office of the President of the Republic of the Philippines, through the Department of Budget and Management (DBM) and/or the Department of Health (DOH) for the release of financial Assistance necessary for the implementation of Republic Act. No. 7305, otherwise known as the Magna Carta of Public Health Workers.

RESOLVED FURTHER, that copies of the resolution be furnished all concerned for their information and action.
