WHEREAS, there is a need to release the funds intended as increase in salaries, as mandated by the Salary Standardization Law for Year 1997;


WHEREAS, appropriate funds have been allotted in the Annual Budget for FY 1997-1998 by the Sanggunian Bayan for this purpose; and

WHEREAS, this time of year is very crucial to the financial needs specially for working parents due to the onset of school enrollment this time of year. Be it.



RESOLVED, FURTHER, that copies of this Resolution be furnished all concerned for their information and action.


