WHEREAS, finding the necessity of said installation, Be it


THEREFORE, RESOLVED, as it is hereby resolved, the Sangguniang Bayan hereby authorizes the Municipal Treasurer




Josefina O. de Jesus to charge the amount of P22,320.00 to the Development Fee of the New Taytay Public Market for the advance and deposits to the Meralco;

RESOLVED FURTHER, that this copies of this Resolution be furnished all concerned for their information and action.


