**RESOLUTION NO. 104**

**EXPRESSING FULL SUPPORT TO SANGGUNIANG  
PANLALAWIGAN NG RIZAL (SPR) RESOLUTION NO. 97-127  
ENTITLED "A RESOLUTION STRONGLY REQUESTING HIS  
EXCELLENCY, FIDEL V. RAMOS, PRESIDENT OF THE  
REPUBLIC OF THE PHILIPPINES, TO ISSUE A  
PROCLAMATION DECLARING THE REMAINING NINETY-  
ONE (91) HECTARES OF LUPANG ARENDA OR LUPANG  
SUWERTE SITUATED AT BARANGAY STA. ANA, TAYTAY,  
RIZAL, UNDER PLAN RS-04-000427 AS RESETTLEMENT  
AREA AND ECONOMIC ZONE UNDER THE JOINT EFFORT,  
CONTROL AND MANAGEMENT OF THE MUNICIPALITY  
OF TAYTAY AND THE RIZAL PROVINCIAL GOVERNMENT".**

WHEREAS, a local government unit must have contiguous territorial jurisdiction and the Supreme Court in a decision more than six decades ago, has ruled that the inhabitants of Taytay have been in continuous possession of the Lupang Arenda, fully described under Plan RS-04-000427 and located at Barangay Sta. Ana, Taytay, Rizal;

WHEREAS, the Municipal Government of Taytay should enact measures that would uplift the social conditions and economic welfare of its constituents;


WHEREAS, His Excellency, President Fidel V. Ramos, through Proclamation No. 704 dated 28 November 1995, has reserved 80 hectares of the total 171 hectares of the Lupang Arenda situated in Barangay Sta. Ana, Taytay, Rizal, for socialized housing in favor of Pasig River squatters;

WHEREAS, there still exist in the Municipality of Taytay numerous squatters and less privileged families in need of a resettlement area and the remaining 91 hectares is a viable site for them;

WHEREAS, SPR Resolution No. 97-127 would be for the benefit and welfare of the constituents of the Municipality of Taytay;

NOW THEREFORE, RESOLVED, AS IT IS HEREBY RESOLVED, that the Sangguniang Bayan of Taytay expresses full support to SPR Resolution No. 97-127 entitled "A Resolution strongly requesting His Excellency, President Fidel V. Ramos to issue a Proclamation declaring the remaining 91 hectares of Lupang Arenda or Lupang Suwerte situated in Barangay Sta. Ana, Taytay, Rizal under Plan RS-04-000427 as resettlement area and economic zone under the joint effort, control and management of the Municipality of Taytay and the Rizal Provincial Government;

RESOLVED, FURTHER, that copies of this Resolution be forwarded to the 1. Sangguniang Panlalawigan ng Rizal, 2. Secretary of the Department of Environment and Natural Resources (DENR), 3. The Manager of the National Housing Authority (NHA) and to all concerned for their information and guidance;
