

B. FOR MOTORIST COMING FROM ANGONO, RIZAL GOING TO CAINTA, RIZAL: FROM THE NEW TAYTAY PUBLIC MARKET, TAKE MANILA EAST ROAD STRAIGHT TO SINGER JUNCTION, THEN TURN LEFT TO E. RODRIGUEZ AVENUE, STRAIGHT; TURN RIGHT TO L. WOOD ST. STRAIGHT TO PULUMBARIT STREET AND OUT TO RIZAL AVENUE.
