**RESOLUTION NO. 88**

**CREATING THE MUNICIPAL FISHERIES AND  
AQUATIC RESOURCES MANAGEMENT COUNCIL  
IN THE MUNICIPALITY OF TAYTAY PROVINCE  
OF RIZAL.**

WHEREAS, pursuant to Republic Act No. 8550, otherwise known as "The Philippine Fisheries Code of 1998" particularly Chapter III, Art. II, Section 73 which states that "the Municipal/City Fisheries and Aquatic Resources Management Council (FARMC) shall be created in each of the Municipalities and Cities abutting Municipal waters";

WHEREAS, the Municipal FARMC shall exercise the following functions:

- a. Assist in the preparation of the Municipal Fishery Development Plan and submit such plan to the Municipal Development Councils;
- b. Recommend the enactment of Municipal Fishery Ordinances to the Sangguniang Bayan;
- c. Assist in the enforcement of fishery laws, rules, and regulations in Municipal waters;

- d. Advise the Sangguniang Bayan of Fishery matters through its Committee on Fisheries, if such has been organized; and
- e. Perform such other functions which may be assigned by the Sangguniang Bayan;

WHEREAS, the regular member of the FARMC shall be composed of the following to wit,

- a. Municipal/City Planning Development Officer;
- b. Chairperson, Agriculture/Fishery Committee of the Sangguniang Bayan;
- c. Representative from the accredited non-government organization;
- d. Representative from the private sector;
- e. Representative from the MPDC; and
- f. At least eleven (11) fisherfolk representatives; seven (7) municipal fisherfolk, one (1) fishworker and three (3) commercial fishers) in each municipality/city which include representative form youth and women sector;

WHEREAS, this Council shall adopt rules and regulations necessary to govern its proceeding and election;

WHEREAS, this Council shall serve starting from the date of their election 2nd Monday of November until the same date and time after three years;

WHEREAS, this Council shall hold Office at the Municipal Agriculture Office, this Municipality;

NOW, THEREFORE, be it resolved, as it hereby resolved, the Sangguniang Bayan duly assembled, hereby creates the Municipal Fisheries and Aquatic Resources Council in the Municipality of Taytay, Province of Rizal;

RESOLVED, FURTHER, that copy of this Resolution be furnished all concerned for their information and appropriate action.

ENACTED, this 5th day of November 1998, at the Session Hall, Municipal Building, Taytay, Rizal.
