WHEREAS, the public demands the immediate solution to expand the present crowded Municipal Cemetery;

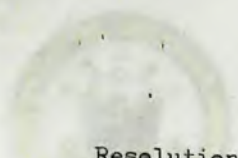
WHEREAS, in order to meet the increasing influx of burials on our Municipal Cemetery;
