DOLORES, TAYTAY, RIZAL AND GIVING AUTHORITY TO THE MUNICIPAL MAYOR JUNE V. ZAPANTA TO ENTER INTO CONTRACT FOR AND IN BEHALF OF THE MUNICIPALITY.


NOW THEREFORE BE IT


RESOLVED, FURTHER, that copies of this Resolution be furnished all concerned for their information and appropriate action.

ENACTED, this 13th day of May 1999, at the Session Hall, Municipal Building, Taytay, Rizal.


