RESOLUTION NO. 93

**A RESOLUTION EARMARKING THE AMOUNT
OF FIVE MILLION PESOS (P5,000,000.00) IN THE
CY2000 ANNUAL BUDGET AS INITIAL FUND FOR
THE ACQUISITION OF A SANITARY LANDFILL/
DUMPSITE FOR THE MUNICIPALITY OF TAYTAY.**

WHEREAS, the problem of garbage and solid waste disposal has been a perennial problem of the Municipality which needs to be given preferential action for its solution;

WHEREAS, there is discontent from the people of Rizal Province who are clamoring for the immediate closure of the San Mateo Landfill wherein the Municipality of Taytay has been dumping a large portion of its daily solid waste collection;

WHEREAS, upon Memorandum from the Office of the President, a Memorandum of Agreement was signed between the Presidential Commission on Flagship Programs and Projects and Metropolitan Manila Development Authority and the Rizal Provincial Government, the Municipality of San Mateo and the City of Antipolo setting the permanent closure of the San Mateo Landfill on December 31, 2000;

WHEREAS, the Municipality should be prepared to address its own problem of waste disposal which will be aggravated by the impending closure of the San Mateo Landfill;

Now Therefore, RESOLVED, as it is hereby resolved, that the Sangguniang Bayan of Taytay hereby earmarks the amount of FIVE MILLION PESOS (P5,000,000.00) in the CY2000 Annual Budget as initial fund for the acquisition of a sanitary landfill/dumpsite for the Municipality of Taytay;

RESOLVED FURTHER, that the Annual Appropriation Ordinance No. 1 of CY2000 shall stipulate that said amount shall not be re-aligned/reverted or used for any other purposes other than for which it was intended;

RESOLVED FURTHERMORE, that the council will pass an appropriate resolution or ordinance in regulation for the use of dumpsite;

RESOLVED FINALLY, that a copies of this Resolution be furnished all concerned for their information and appropriate action.




