business opportunities to Rizaleño;




RESOLVED FURTHER, the copies of this Resolution be forwarded to Sangguniang Panlalawigan for their appropriation regarding this request;

ENACTED, this 9th day of September 1999, at the Session Hall of the Municipal Building, Taytay, Rizal.


